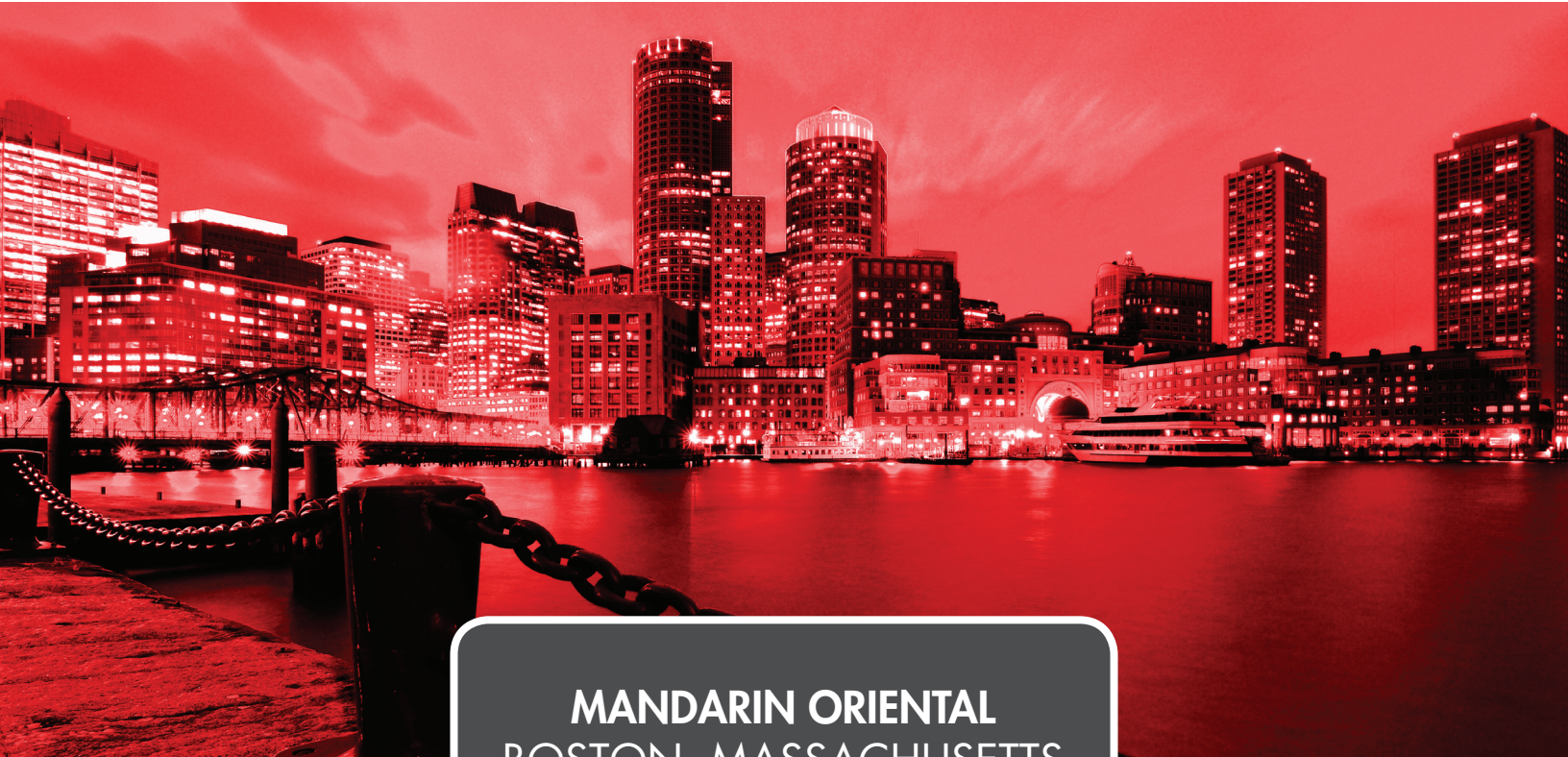

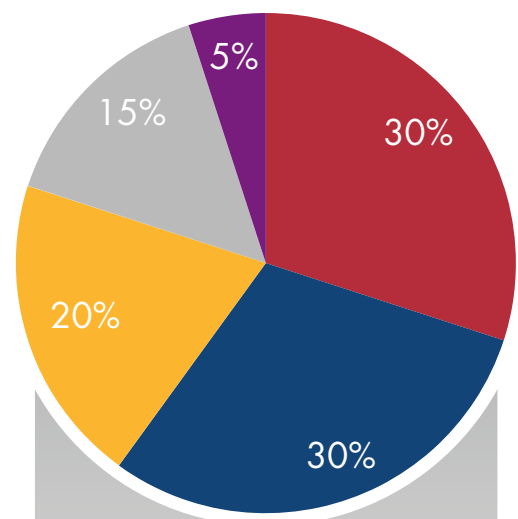

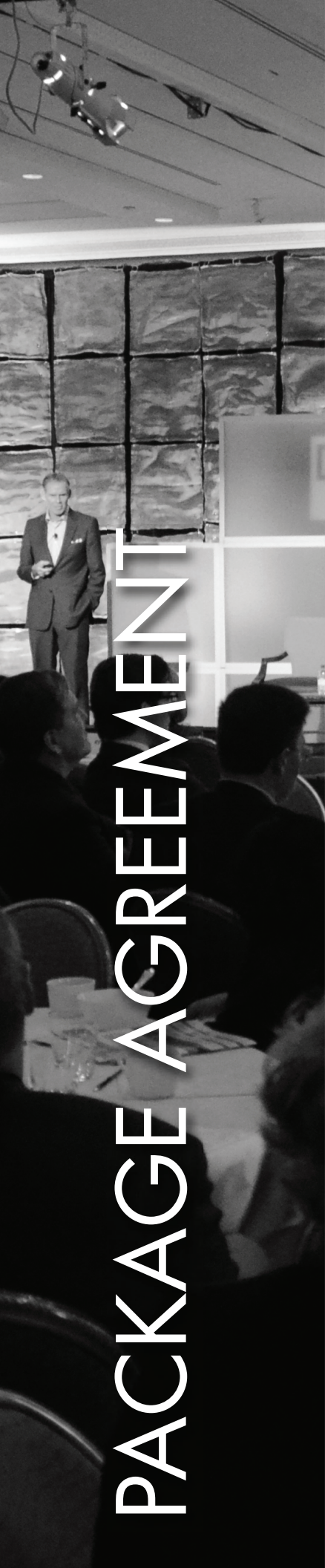
This "2016 Healthegy Companies to Watch" Agreement with Healthegy goes into effect upon receipt of signed proposal.
